Thank you for taking the time to attend the meeting and submit your comments relative to your primary residence located at ██████ N. Peterson Ave. Your comments are summarized below, and your comment form is attached for reference.

**Summary of Comments** – During heavy rains, sewage backs up in the driveway and yard.

**Response to Comments** – As a follow up to the IOAP meeting, Mr. David Schaftelin and Mr. Glen Cooper met you on site to discuss the issue. Also, a review of our records indicates that MSD has been called to this address several times over the last several years to investigate this issue. There does appear to be a recurring problem with root blockages in this sewer, which have led to the multiple problems and possible discharges from the sewer. The fact that a stormwater grate is adjacent to the sanitary manhole cover also sometimes makes it difficult to determine which one has surcharged after any particular event is over.

In order to more aggressively deal with the potential blockages in the sanitary sewer, MSD will once again telespect the sewer line and mechanically remove or chemically treat any roots or other blockages found in the sewer. As always, please contact us anytime you witness what may be an overflow from the sanitary sewer system. 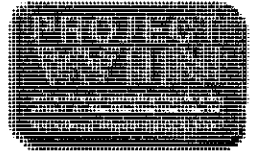
