Attention Chiefs and Director:

Attached are requests for approval of proposed minor project modifications to the I-64 and Grinstead Drive Storage Basin project (IOAP Project No. L_MI_MF_127_M_09B_B_A_8) and the Clifton Heights Storage Basin project (IOAP Project No. L_MU_MF_154_M_09B_B_A_8). These requests are proposed revisions to requests previously provided in our letters dated September 20, 2012. These modifications are part of the ongoing adaptive management review of the approved 2009 IOAP that has been documented in the 2012 IOAP Modification to be formally submitted in 2014.

In our September 20, 2012, transmittal of a series of minor modification requests we demonstrated that the full suite of proposed modifications do not fundamentally or substantially change the approved schedule or performance objectives of the approved 2009 Integrated Overflow Abatement Plan. In fact, the full suite of proposed modifications achieves overflow control at a faster rate and to a greater extent than is proposed in the approved Plan. These two proposed revisions change storage basin sizes and add stormwater diversions and green infrastructure practices to the approach, but do not modify the proposed schedule or level of overflow control as presented in the September 20, 2012, requests.

I certify under penalty of law that this document and all attachments were prepared under my direction or supervision in accordance with a system designed to assure that qualified personnel properly gather and evaluate the information submitted.
