Dear

Thank you for taking the time to attend and submit your comments relative to the Integrated Overflow Abatement Plan at the May 15, 2012 meeting. Your comments are summarized below, and your comment form is attached for reference.

Comment 1 – Will blasting to install the new sewer interceptor affect the existing bridge?

<u>Response to Comment 1</u> – The design of the Upper Billtown Interceptor Project indicates that the installation of the sewer will most likely require rock removal. Prior to any rock blasting the contractor must follow regulatory requirements and perform pre-blast surveys of structures within the required limits. The contractor will be held responsible for damage to structures directly related to rock blasting.

Comment 2 – Will the contractor use the existing bridge for construction traffic?

Response to Comment 2 – The design of the Upper Billtown Interceptor Project includes a low water crossing for construction equipment within the vicinity of the existing bridge. Therefore there is no reason for the contractor to need use of the bridge without prior approval from the property owner. If the use of the bridge for construction traffic is a concern of the property owner then the property owner should request this, as well as any other condition, be included in the Special Conditions of the Easement. This will help ensure that the request is included in the project contract documents.
