Dear

Thank you for taking the time to submit your comments relative to I-64/Grinstead CSO Basin and the Lexington/Payne CSO Basin Projects. Your comments are summarized below, and your comment form is attached for reference:

Comment - Please consider locating these basins on the River City Metals property.

Response to comment - The exact location and size of these CSO basins has not been finalized. The proposed locations of these projects contained in the IOAP were based on the ability to collect multiple CSO's to a single basin and on an initial review of available property in the immediate area. Efforts are currently underway to focus on the recalibration of the hydraulic models used to size these facilities, which may result in significant changes in size of these proposed facilities. Consolidating the basin proposed in the vicinity of I-64 and Grinstead with the basin proposed for the vicinity of Lexington Road and Payne Avenue was explored and rejected in the initial planning evaluation. Given the potential for a significantly larger basin at I-64 and Grinstead and concerns about siting a basin in this area, the consolidated option will be reviewed again, along with other project locations and configurations. Prior to finalizing a decision on a location or size of any of these facilities, MSD intends to invite further public comment.

The revised I-64 & Grinstead Drive basin projected size and cost will be presented at the next Public Input Meeting scheduled for Tuesday, January 24, 2012. At that time we will discuss a broad range of approaches that are still under consideration for controlling CSOs in this area. MSD invites you to attend this meeting which will be held at the Kentuckiana Girl Scouts Headquarters on Lexington Road at 6:30 pm.
