Dear

Thank you for taking the time to submit your concerns about a broad range of issues related to our IOAP, water quality and issues related to new development in the Fern Creek area. A transcript of your verbal comments and a copy of your letter are attached for reference.

We appreciate your opening comments commending our ongoing efforts related to Green Infrastructure and the partnerships that have developed. Louisville MSD is recognized as a national leader in this area, and we continue to believe that implementation of Green Infrastructure initiatives can result in both water quality improvements as well as the reduction in size of some of the required "grey" components of our Consent Decree. In essence, the large majority of everything that MSD does has a direct connection to improving water quality in the streams and creeks of Jefferson County as well as the Ohio River; as such we share many of the goals that you mention.

In particular, this letter serves as MSD's response to the specific comments related to developments in the Fern Creek area.

Response to comment 1 - Johnson Green Condominiums — the issues related to a "hidden zoning change" that you reference as well as a buffer that was removed are issues related to planning and zoning, and not MSD. Metro Planning and Design has the overall role for ensuring that all development in Jefferson County complies with the Land Development Code and overall planning and zoning regulation. MSD does not have a role in planning and zoning issues.

Response to comment 2 - Birchwood Treatment Plant – like all small package wastewater treatment plants, the Birchwood plant was plagued with problems, particularly in the last few years that it remained in operation. All of these small plants were built by private developers and were originally intended to be "temporary" solutions to wastewater treatment until a comprehensive collection system was available. Many people have forgotten that

Jefferson County used to be the home to over 300 of these facilities constructed in the 1960's and 1970's, a great many of which discharged poorly treated effluent directly to our waterways. Only through MSD's watershed action plans and sewer expansion efforts over the last 40 years have most of these plants been eliminated. As of today, there are less than 20 of these facilities remaining in our service area, all of which we intend to have eliminated in 2017. It is ironic to us that this very type of expansion effort which will eliminate similar facilities in the Chenoweth Run watershed has come under such heavy scrutiny by those claiming to be interested in improving water quality.

The Birchwood plant site is currently owned by MSD. As a result of eliminating these small treatment plants MSD now owns numerous parcels of property in Jefferson County. The ownership of many of these parcels reverted back to the developer after the treatment plant was eliminated. While we currently mow these properties and provide the maintenance necessary for public safety and nuisance avoidance, MSD does not have the resources to invest in landscaping and landscape maintenance of the properties that are scattered around Jefferson County. While the landscaping of the Birchwood site would certainly help it's appearance, we are not able to offer the same to other neighbors across the District, and MSD does not think that this is a wise use of our limited resources. MSD would be glad to discuss allowing others to use/landscape this area if there is an interest from the local residents or an active Neighborhood Association.

Response to comment 3 - Cedar Springs Apartments – like all new development in Jefferson County, the plans for sanitary sewers and drainage plans for this development underwent review by MSD. MSD uses nationally accepted engineering practices and design standards as part of this review, as detailed in our Design Manual (available on our public website). Of course, all drainage from any new development in the Cedar Creek watershed will drain into Cedar Creek, just as the pre-developed land did. MSD design standards generally result in peak post-development flows being equal or less that pre-developed flows. This is generally accomplished by onsite detention/retention, although MSD staff also have the ability and flexibility to simply collect Regional Facilities fees if there is a technical basis which justifies this as a better alternative to an on-site solution.

There is a common misconception that MSD can or should "deny" new developments in response to concerns of local residents. The fact of the matter is that if a development can meet established criteria for sewer and drainage facilities, MSD has no ability or basis to deny them. As noted in our response to comment number 1, the appropriate place for public input on new development is with Louisville Metro Planning and Design.

Response to comment 4 - WalMart — Your comments related to this development deal exclusively with planning, zoning and traffic issues; MSD has no jurisdiction over any of these issues. As noted in our response to comment number 1, the appropriate place for public input on new development is with Louisville Metro Planning and Design.

Response to comment 5 - Stoneledge Subdivision – The removal of trees and installation of sewers, storm drains, various utilities and roads are required to build a subdivision. MSD has little, if any, control over how a developer chooses to design and configure their development, or which trees they choose to remove. The design and alignment of all sanitary sewers, including stream crossings, are reviewed by MSD and Kentucky Division of Water (KDOW) for compliance with applicable standards. As noted in our response to comment number 1, the appropriate place for public input on new development (including issues like appearance and configuration) is with Louisville Metro Planning and Design.

**Response to comment 6 - Anderson Park** – please see the response above related to Cedar Springs Apartments. MSD has no authority related to traffic.

Response to comment 7 - MSD Cedar Creek Treatment Plant - This plant currently has permitted capacity to accept the portion of the flow that is planned to be diverted to this plant by the elimination of the Jeffersontown Water Quality Treatment Center. The tracking and review of existing capacity at our treatment facilities is closely monitored by KDOW, and we are required to work within the constraints contained in our existing permits.

Response to comment 8 - Your statement that local residents can't get sewer service is inaccurate. Groups of property owners may petition MSD for sewer service at the Cedar Creek WQTC, which will trigger the beginning of a process which allows owners to "vote" for sewers based on a cost guaranteed by MSD. In 2007, residents of Fern Creek Road and Lovers Lane took advantage of this opportunity; the majority of owners voted against the installation of sewers, and the project was stopped. MSD currently has no active petitions on file for any projects in the Cedar Creek/Fern Creek area.

You have a longstanding history of environmental stewardship, and while we may not always agree on details, we believe we share many fundamental goals. Thank you for all of your comments and suggestions, and for taking time to attend our meeting. MSD invites you attend future IOAP Project Input meetings, including the next meeting scheduled on Tuesday, January 24, 2012. The meeting will be held at the Kentuckiana Girl Scouts Headquarters on Lexington Road at 6:30 pm.
